		Due to rising costs in material, labor and climbing interest rates, the Common Council approved an \$11 million additional investment in the JDS project to keep the redevelopment on track. The return on investment will be 12 years, which is a reasonable payback period for this type of project.

		Budget goals in event revenue are being met this year. The pace for banquet and meeting bookings has slowed; however, it's being made up for in conventions and conferences. The average spend per event is exceeding the budget.
7.	<u>51644</u>	Finance Report: Jeff Boyd, Business Manager
		The month of April ended with a revenue surplus of \$65,000. This may be accounted for by the increase in spend per event. The budgeted number of banquets was 15 at \$4,500 per event. The actual number of banquets was 17 at an unprecedented \$10,166 per event. Even with 43 less events this year, revenue is ahead of 2016—a record breaking year. 2018 is on target to end with event revenue up 7% and overall revenue up 5%.
