 53588 Peer Support Update: Presentations by Madison-area Urban Ministry and Nehemiah Community Development/Focused Interruption Coalition

Nancy Saiz gave an overview of peer support services and introduced the presenters.

Linda Ketcham, Janie Osecko, James Morgan and Janee Hawk from Madison-area Urban Ministry (MUM) discussed their program. 35 people took the class and 20 passed the certification exam to become peer specialists. MUM gets formal nad informal referrals for the program. They walked through the intake process. 50 individuals year-to-date received case management services, 23 are currently in the program. They discussed a specific case of mentoring someone who has recently been released from prison. They described the training process. MUM has been a partner in re-entry since 2013.

Anthony Cooper, Zandra, Jerome Billard, and Aaron Hicks from Focused Interruption Coalition (FIC) disussed their crisis response peer support program. They are staffed on call 24/7. Every time there is a violent crime, they respond. 12 individuals took a test for Forensic Peer Support Certification, and 4 passed the exam. They discussed their partners, Nehemiah, Public Health, Anesis, Madison Police Dept, CSIT, UW Hospital and Clinics, and where their referrals come from. Crisis response is to midigate the effects of trauma, and for de-escalation purposes. Participation is voluntary, and not every person they come into contact with becomes a participant. Participants get one-on-one support. They have 24 active participants, with 14 being high risk. They also have 17 active participants in the juvenile program that have been involved in shootings. There have been 39 incidents year-to-date. 6 homicides (2 in Fitchburg), 16 involved shots fired, 7 de-escalation situations, 18 SIU/Juvenile justice, 15 contacts with the shooters. They described their work with juveniles and how it differs from working with adults.
