- Lease and Rent Comparisons
- Function or percent of sales lease structure. Vendor accountability can be a challenge. A common POS provided by the market can limit this challenge.
- Cash sales different rent structure
- Permanent vendors are normal retail
- Non-long term tenant are discounted rent/or subsidized
- Loading and Storage
- Some market offer no storage or limited storage
- Farmers did not want storage but may want some in their stalls
- Market operators said they recommend storage Experienced Market Managers recommended to think about future needs of the market
- Fee based \$10/sq ft for storage
- Box truck and accommodate two vehicles at a time
- Did have a street scape for semi load-in
- Parking
- Recommend 90-120 dedicated stalls
- Researching a transportation management plan and alternative off-site parking within 8 block
- Review Cap East Parking study
