8. 52894 Informational Report on Journey Mental Health Program, Kajsiab House

Kajsiab House is a case management program of Journey Mental Health for approximately 60-90 unduplicated older individuals from Cambodia and Viet Nam, supported by City of Madison funding. The program started in 2000 was notified on August 6 that Journey was ending it on September 28. An additional 70 older persons are served at home. Doua Vang and Mai Zong Vue reported on this "home-away-from-home" that offers socialization, safety, companionship and support to those who have been impacted by war, multiple losses and disenfranchisement by virtue of language and culture. Clients are distraught about the situation, and CoA members wanted Donna Bryant to express their concerns at the CSC meeting. They encouraged Beatty to speak to her superiors regarding a delay in closing this important facility, so other plans might be implemented for the good of this population.

REPORTS

1. 43424 Madison Senior Coalitions Report

Hendrickson reported on the status of the merger. Messages to clients, participants, staff and community are the same and the transition is anticipated to be seamless. Clients will have same Case Manager; programs will remain. Westside utilization is increasing with move, and "entity" marketing plan and HR policies to be completed by September 11. New name by the next CoA meeting.

2. 48103 Community Services Committee, Donna Bryant

The committee discussed and accepted recommendations for the awarding of Community Building and Engagement grants; Progress Center \$45,000, + 2018 funding \$11,250 and Bayview \$37,475 and Vera Court \$24,525. Will go to the Common Council September 4th. Discussion about the remaining funds for 2018 and determined to extend the two current contracts for Lussier/Goodman and Centro Hispano. The committee also requested additional funds in the 2019 budget.

51726 Madison Senior Center Foundation, Edna Canfield and Kathy Whitt

Board members approved request of \$900 for North Eastside Senior Coalition Artful Aging project. Staff submitted an application to co-brand a fund raising campaign with Madison Community Foundation. Canfield commented favorably on potential new member Ron Luskin, who is on the agenda for approval.

That the Madison Senior Center should pursue and maintain national senior center accreditation now and in the future was moved and unanimously approved on the motion of Poi and Rimkus.
