Assistant City Attorney (ACA) Brisk attended the meeting to be available for questions from committee members. It was shared there is a State Statute and the ordinance replicates the State Statute. There was discussion on whether there could be a change in the fine amounts. ACA Brisk indicated there could be suggestions to the fine amounts. Petzold recommended a substitute to double the amounts to raise upper limits to not more than \$4,000 of a weaponized drone and the deposit amounts increased to \$2,000. Anderson seconded the motion. The motion passed unanimously.

Laura Larsen the Budget and Program Manager for City of Madison Finance Department shared a powerpoint on the city's budget process. Ms. Larsen went over the Fire and Police Operating and Capital budgets sharing general funds, agency requests, and supplemental requests. The Finance Managers from both of the departments went over specific planned projects. There was a specific request for the fire department to detail information on the communications equipment request projected for 2024. There were questions on staffing directed to the police department. A few years back the department used Etico, a staffing study to determine staffing needs. The department continues to use the same format to project staffing numbers. The study will be sent to the committee. Overtime costs and projections for both of the departments was an item of interest and a request for each department to share overtime costs as a future agenda item.

Another suggested agenda item was to have a better understanding of overtime from the Fire and Police Department and the stress it creates on personnel. Understanding what kind of things that are leading to the amount of overtime.

The last item was strategic planning for the committee and our charge as a committee. Development of annual and long-range goals.
