Alder Zellers and Laura Larsen from City of Madison Finance shared information on Version 2 which is a substitute resolution (Analyzing Alcohol Outlet Density). Version 2 will "direct the Finance Director and other stakeholders to analyze alcohol outlet density and to perform data and

research on issues that are related to excessive alcohol consumption that result in disproportionate calls for service". Alder Verveer, Wood, and Zellers worked together as an Ad Hoc Committee to address alcohol violence in the downtown area. They learned the Mayor was working on something similiar but his was for an alcohol moratorium in the downtown area on the issuance of new alcohol licenses. Alder Zellers recommended adoption of Version 2. Mustajab Abbas seconded the motion. Alder McKinney abstained from voting because she was not present during the discussion. Motion passes.

# **NEW BUSINESS**

3. <u>53725</u> Madison Police Department Mission Statements

Attachments: Proposed Mission Statement for the Madison Police Department Units (002).

Recommendation #31 from the OIR report asks for "input from the community, each specialized Madison Police unit that has not already done so should devise a mission statement setting out the core objectives of the unit". There were twenty- two mission statements shared with the committee created from the respective units. The committee began to go through each of the mission statements but with questions and varying suggestions on language changes made it difficult to come to a consensus. The committee also looked at the organizational chart and thought some of the unit and sections were missing mission statements. The request was to include a mission statement for Investigative Services, Gang Unit, Burglary Crime Unit and Victims Crime Unit. After determining the best route to go through the mission statements the suggestion was for committee members to go through each statement on their

own. If recommending a change it should be shared with Emily Hardiman by December 4, 2018. Emily will work on creating one document to share with the PSRC at the December 11 meeting. At that time the committee will go th rough the suggestions/changes and work together on a consensus.

4. <u>53726</u> Discussion on the preparation of the OIC recommendation from the Policy and Procedure Ad Hoc Committee

There was discussion on each committee member taking a section of the OIR report reading it and report back to the committee. The decision was to wait until the report is final. For now, the committee should take the time to read the entire report.

#### **REPORTS**

5. <u>53728</u> Report from the Madison Police Department

An Open House took place at the new Midtown Station on October 18. Freakfest attendance was down this year and there were 14 arrests with individuals cited and released. The annual assignment process will be completed the week of November 12 and on December 30 Command Staff moves into their new positions. Parking Enforcement has a new management system that is smart phone based and will be ready to go in the next couple of weeks.

6. <u>53729</u> Report from the Madison Fire Department

Information was shared from the attached report. There was discussion on decontamination buckets that help firefighters get rid of harmful contaminants when working with structure fires from their skin, uniform, and gear. Another topic of discussion was firefighters working long hours and the health risks associated with that. Assistant Chief Christenson shared there is research in the works with studying working long hour shift/days.

7. <u>53730</u> Report from Alders

Alder McKinney shared Council will work through budget deliberations the week of November 12. There will be money allocated for professional writers to work with the Ad Hoc committee on the final OIR report.
