A motion was made by Findley, seconded by Braunginn, to endorse recommendation 34 amending the language to read, "MPD should consider resource neutral ways to supplement the staffing of their facilities and also

explore alternative shifts and hours so that they can be open for public access for longer hours." The motion passed by voice vote/other.

A motion was made by Yudice, seconded by Jorgensen, to endorse recommendation 38 amending the language to read, "MPD should collect and document information pertaining to the work of neighborhood officers and other specialized officers either through daily logs or through such other data collection methods that the department deems appropriate that generate comprable data." The motion passed by voice vote/other.

A motion was made by Braunginn, seconded by Albouras, to endorse recommendation 39 amending the language to read, "In order to be able to gain an evidenced-based understanding of patrol officers' problem-oriented policing activity, MPD should develop a system to track and report the specific efforts including results, ongoing efforts, and collaboration with community groups." The motion passed by voice vote/other.

A motion was made by Braunginn, seconded by Saiz, to endorse recommendation 40 to include the clarification from OIR that this would be completed in conjuction with the neighborhood as laid in recommendation 41.

A motion was made by Braunginn, seconded by Jorgensen, to endorse recommentation 46 amending the language to read, "MPD should track and evaluate the substantive work of its Community Policing Teams to ensure consistent application of community policing principles based upon best practices of community policing apart from traditional law enforcement methods."
