City medical personnel who may be tasked with providing clearance should be consulted before guidelines are changed." The motion passed by voice vote/other.

A motion was made by Yudice, seconded by Braunginn, to endorse recomendation 99, amending it to read "MPD should modify its prohibition on shooting at moving vehicles to read 'Firearms shall not be discharged at a moving vehicle unless: (1) A person in the vechile is threatening the officer or another person with deadly force by means other then the vehicle; or (2) The vehicle is operated in a manner that resonable appears deliberately intended to strike an officer or another person, and all other reasonable means of defense have been exhausted (or are not present or practical).'
