-Early Childhood Care and Education Committee

-Committee on Aging

Mykenzie Lemberger reported that the Early Childhood Care and Education Committee has not had a meeting. In July they will be discussing the Dream Up Grant and an update to the accreditation standards.

Donna Bryant reported that she had just come from the Committee on Aging meeting. They were discussing recommendations for the Southeast Asian Senior Services. They did not get to recommending, as they had many people wishing to speak at public comment, and they lost quorum. They will continue the matter at the July meeting.

#### 5. 45406 Staff Report

Your recommendations for neighborhood center and school-age child and youth funding processes went to Finance, and they agreed with the tiered funding level you recommended. The RFP for neighborhood centers was posted a week ago, and this Monday, the non-neighborhood centers school-age child and youth program RFP was posted.

We are finishing up the Safe Passages RFP process. Mellowhood received the recommendation for funding, up to \$125,000.

We are selecting a service provider to suceed The Road Home at the Tree Lane PSH complex. The Salvation Army and Sankofa are the two applicants. We are preparing three versions an operating budget for 2020, cost to continue, 2.5% cut and 2.5% increase budget.

We are in the midst of the hiring process for a CDBG manager and getting ready to post Laura's position.
