PUBLIC HEARING ITEMS

1. <u>55296</u>

4916 E. Broadway - Comprehensive Design Review for Dane County Data Exchange, LLC Located in UDD No. 1. 14th Ald. Dist.

The motion approved the signage only with the clock to be placed in a different location of the owner's choice. The motion was approved with the finding that all applicable standards are adequately addressed and with all the staff recommendations contained in the report as follows:

- The provided site plan shows the parking lot modified to install the ground sign. This will
 require site plan review before the ground sign is issued.
- Art renderings will include lighting details in the final CDR.
- Any additional ground or wall signage would require a new review from the Urban Design Commission.

A motion was made by Weisensel, seconded by Braun-Oddo, to Grant Final Approval. The motion passed by voice vote/other.

55394 5565 Tancho Drive - Comprehensive Design Review for Oakwood Village Prairie Ridge.
 17th Ald. Dist.

The motion noted that not enough information was provided for a typical Comprehensive Design Review, and for the purposes of equity this information is needed. It was further noted that photographs showing the hill, the street and the entrances, with the new designs superimposed at the right scale would be beneficial in helping the Commission reach a decision.

3. 55395 6918 Seybold Road - Signage Exception from UDD No. 2. 19th Ald. Dist.
