PRESENTATIONS

1. 100% Renewable Madison Updates

Mahanth Joishy, the Superintendent of Fleet Services presented an update on efforts to address reductions in greenhouse gas emissions (GHG) and fossil fuel use in fleet of 1400 City vehicles. He reviewed efforts in four areas that would help support the renewable energy and emissions reduction goals of the Energy Plan--use of biodiesel, electric vehicle (EV) conversion, EV/Hybrid conversion and anti-idling technologies. PowerPoint presentation will be forwarded to Committee for distribution with minutes. Joishy updated group that in past 5 years GHG emissions have been reduced by 5%.

Green and staff educated the Committee on integrated pest management basics, the history of the Task Force and the link of IPM policies and practices to the system conditions of the City's The Natural Step (TNS) sustainability framework. Committee members were advised to read the IPM-PRTF Final report and the IPM Recommendations Summary Annotated report to gain further background and insight on the issue.

6. SMC Planning Process

Co-chairs, LeClair and LeZaks, reviewed ideas around creating working groups to work on specific sustainability issues. Potential working groups could include Community-wide energy goals, Community Engagement, Resiliency Planning and restructuring of three sustainability committees into one. Committee members were asked to think of areas of interest to them and ideas for working groups, plus ideas for future meeting agenda topics. Co-chairs and staff would like to develop a list of agenda topics to cover in 2020. Committee members concurred with this.

Next meeting is December 18th. Meeting dates in 2020 will be on fourth Monday of the month, except for two months being moved forward because of established holidays. List of dates will be given to the Committee at the next meeting.
