Assistant Attorney Zilavy shared an update of where the abatement process is at with Tree Lane. The abatement plan was submitted to Heartland. Some of the issues addressed were invalid leases and a revised lease/visitor guest policy. The updated visitor policy was well recieved by residents. Calls for service at the complex have trended downward. There were two interviews conducted recently for a new property manager. ROAD home has been a positive change connecting with residents and behavioral issues. There are still a few families who are creating disturbances and work is being done to address those problems/issues.
