Update on Bloomberg Harvard City Leadership Initiative (https://www.cityleadership.harvard.edu/)

City was accepted into their Innovation Track to provide assistance on a project around Transportation Demand Management. City staff involved come from Transportation, Finance, Human Resources, Engineering, Transportation, Madison Metro, Public Health, Parking Utility, Streets, Library and Planning (12 staff and team lead is Adam Pfoust from PCED).

Also applied for technical assistance from Bloomberg Associates. City submitted projects on Green Infrastructure, Anti Displacement, Vision Zero and Climate Resilience (may get one).

# **Update on hiring of DPCED Director**

In the process of hiring a director (see news media articles on finalists). Ald. Bidar asked what the timeline was for hiring the director. Mayor hoped in the next week or two to make a decision, needed to contact references.

Update on Police & Fire Commission / Hiring Chief of Police
They have been having conversations with the PFC around the process of
hiring a new chief: community engaged process, outreach. Offered support in
their hiring process (e.g. funds for hiring a search firm). Ald. Bidar asked if
there was a good way for the PFC to keep the Council informed on their
process. Mayor has will ask Deptuy Mayor Cam McLay, who is attending the
meetings, to communicate information to the alders. She will also request the
chair of the PFC to find a way to communication with the alders.
