3. 61824 Transportation to Madison Senior Center and Bus Rapid Transit Overview- David Trowbridge, Michael Cechvala, Drew Beck

Bus Rapid Transit (BRT) information and powerpoint is shared, followed by discussion of the current local bus stops in close proximity to MSC. CoA proposes a stop be situated right in front of MSC. This topic has been

raised before, limited options but they will bring back to the service route

planners to revisit possibilities.

Staff share participant concernst: cost of parking is prohibitive, a two block walk can be difficult, safety in the downtown area, and may not be comfortable driving downtown.

Consider bringing NewBridge in on the conversation to help coordinate transportation options.
