Action Items:

- TC Agenda setting - fewer information items and more action items on future TC agendas.

- Crossover/Chair - TC formalize written policy guidance request to TPPB process.

- TPPB - TPPB create a subcommittee to work on policy initiatives.

- Staff - Definition of 30% and when does it come back to the bodies.

- Staff - Review BPW ordinance and define the relationship between TC & BPW.

- Staff - Get plans to TPPB as they are being made/earlier than they are currently receiving them.

- TC - TC members review list of 'Powers and Duties' of the TC in the ordinance.

Deputy Mayor Leslie Orrantia introduced herself and stated her role in transportation and economic development, and as a state lobbyist overseeing regional relationships in collaboration with County and Federal efforts.
