Motion passed by the following vote: Approve - Ald. Sheri Carter; Marla Eddy; Ald. Keith Furman; Jackie Suska; and James Wolfe. Abstain- Dan McAuliffe.

Motion made by Furman, seconded by Carter, to recommend that the word "February" be changed to "April" in the BE IT FURTHER RESOLVED section of Legislative File 55206 (v.2). Motion passed by voice vote/other.
