1. <u>57635</u> Poet Laureate Selection

Adam Pergament, also known as FlowPoetry, recited one of his poems in support of his Poet Laureate application, and thanked Oscar Mireles for his service as Poet Laureate. He also invited commissioners to his poetry book release event this coming Monday, November 18, at High Noon Saloon; Jason Robert Van Pelt spoke in support of his Poet Laureate application and recited the poem, "Memory" by Abraham Lincoln; Rachel Werner spoke in support of her Poet Laureate application.

Oscar Mireles sat at the table with MAC for the discussion of the Poet Laureate decision. He described the many skill sets necessary for this position including: organization, social networking, and patience. He mentioned the demands of the position, especially managing Bus Lines and vetting all the applications. He also advised MAC to consider a generational shift in picking the next poet. This is a position that is about passing the torch.

MAC asked staff to draft a one page speaker form about booking the Poet Laureate. Yvette would like to suggest that Jason Van Pelt and other poets be given more opportunities to participate in civic projects. Sheri spoke to the importance of having a Poet Laureate speak at the Common Council meetings. MAC suggested having an open nomination period, then the Poet will be invited to supply the application material. Nominations have to be early enough that there is time for the nominated poet to submit an application.

A motion was made by Pino, seconded by Rodriquez, to consider Rob Franklin and Angie Trudell Vasquez as the two top choices for Poet Laureate. The motion passed by voice vote/other
