The Mayor provided an update on the following:

Reopening and Recovery Plans for the City of Madison

-Referenced the Forward Dane Plan - details the process for reopening (https://bit.ly/2WN2FSf)

- -Provided an update on the redeployment of city staff by services types.
- -Noted that there is an internal planning task force of the EOC working on reopening city services: preparing physical spaces, preparing staff to return to offices, preparing staff to expand field work (e.g. home inspections), preparing/expanding services to the public.
- -Reviewed the COVID-19 Funding and Recovery Team Structure (see attachment) their work would continue through end of year/into next year.

Ald. Kemble asked how the boards, commissions and committees and Performance Excellence teams would integrate with this structure. Mayor stated that each box (staff) had a primary/secondary BCC that they were responsible for providing information to. She noted that there had not been a conversation with the Performance Excellence teams yet but would consider.

Ald. Henak asked how to contact city staff given the new team structure. Mayor stated that alders should continue sending requests to Kwasi Obeng.

- -Referenced the Wisconsin Supreme Court 5/13/20 vote to invaldiate the Safer at Home order issued by the Wisconsin Department of Health Services and how the city and county provided local order (Forward Dane).
- -Not much going on at the State currently, some election issues, CARES Act funding from Governor's office (e.g. rental assistance), State revenue loss projections are concerning for City 2021 budget (aid cut), encouraged alders to contact our congressional delegation to encourage them to support the HEROES Act (https://bit.ly/2zQAnNV).

A motion was made by Henak, seconded by Abbas, to RECOMMEND TO COUNCIL TO ADOPT - REPORT OF OFFICER.

Ald. Marsha Rummel explained that this ordinance codified what the CCEC already does.

City Attorney May noted that the ordinance provides two clarification to the appointment of the Common Council Executive Committee. First, it clarifies that the newly elected President of the Council is to make the appointment as

soon as practicable after the organizational meeting. Second, it clarifies that the appointments are subject to confirmation by the Council.

Ald. Abbas moved Ald. Carter's proposed amendment, seconded by Ald. Henak.

Add the following sentence at the end of sec. 33.13(1):

"The terms of all members of the CCEC end at the annual organizational meeting of the Council and are not subject to the extensions provided in sec. 33.01(6)(d), MGO."

Motion to amend the main motion was approved.
