Superintendent or representative.

The Mayor and MMSD Superintendent have representatives at the table. The Dane County Executive does not. The committee discussed the representation vs. voting rights for members.

Motion by Wegleitner, seconded by Evers to modify ordinance 33.28 of City, County, Schools Collaborative Committee membership to establish the Mayor or designee and the Madison Metropolitan School District Superintendent or representative positions as ex officio non-voting committee members.
