A motion was made by Hamdan, seconded by Boggess, to Approve the Minutes of the April 13 meeting. The motion passed by voice vote/other. Mary Schauf abstained, not having been at the previous meeting.

# FIRE DEPARTMENT DISCUSSION ITEMS

1. <u>60417</u> Update on the 2020 Fire Department Hiring Process

Assistant Chief Tracy Burrus updated the commissioners on the hiring process for 2020. Chief Stephen Davis reported that he has been working with Human Resources to continue moving forward with the hiring process during the pandemic.

Consideration and possible action on the request of Chief Davis to extend the 2018 Fire Department Eligibility list to September 1, 2020.

A motion was made by Schauf, seconded by Boggess, to extend the 2018 Fire Department eligibility list through September 1, 2020. The motion passed by voice vote/other.

3. <u>60419</u> Update on 2020 Apparatus Engineer Promotional Process

Assistant Chief Burrus reported on the scheduling of the written exam for May 26 in compliance with social distancing guidelines.

#### POLICE DEPARTMENT DISCUSSION ITEMS

4. 60420 Update on the Hiring Status of the 2020 Police Department Academy

Captain Jennifer Krueger Favour reported on the 2020 academy process, which is proceeding as normal. The 2021 process is also proceeding, although the written exams and physical agility exams are postponed to October and November due to COVID. The oral board interveiws are postponed to June.

Captain Krueger Favour provided an update on temporary acting assignments.

6. 60422 Recommendation of Acting Police Chief regarding promotions and appointments and schedule personnel file review

Captain Jennifer Krueger Favour presented the recommendations of Acting Police Chief Victor Wahl.

7. General status report on Police Department discipline

There are three open disciplinary cases, but no suspensions.

Acting Chief Wahl explained the role of the Madison Police Department in enforcing complaints referred by Public Health in response to questions from Commissioner Gundlach.
