The commissioners agreed to use the proposed timeline as a flexible working draft to guide the process. They expressed both the need to be flexible in potentially expanding the time allowed for public input and also the strong desire to conclude the hiring process by the end of 2020. Adjustments will need to be made to ensure that all commissioners can be involved in all interviews, including adjusting the meetings near the end of October and beginning of November.

PERF will present an amended timeline at the July 22 meeting. The commissioners will consider adding meetings as needed to meet goals.

Mike Quieto reported on additional help and resources offered by the City Clerk's Office.

Commissioner Boggess will reach out to the Local Voices Network to finalize their involvement, specifically, asking them to host online sessions with one commissioner as a participant and to finalize the number of sessions.

Commissioner Hamdan will coordinate outreach to radio call-in shows to solicit live input in the community, such as La Movida, WORT, WPR, or a Madison 365 podcast.

Commissioner Gundlach will coordinate a community survey with PERF.

Commissioners Trammel and Schauf will coordinate public webinars and Zoom chats. She will also reach out to community centers and libraries for assistance.

All commissioners will give an update on their progress at the July 22 meeting.
