DISCUSSION ITEMS

27499 Public Market Discussion

- Matt Mikolajewski provided an update on the 2021 Mayor's Executive Budget, which has full reauthorization of \$7m from TID #36 for Pubic Market.
 Finance Committee will look at budget next than go to the Common Council in November.
- Mikolajewski gave overview of Economic Development Administration (EDA) Grant requirements.
- Anne Reynolds provided overview of conversation with EDA staff. Grant will be for construction.
- Reynolds informed committee The Foundation has contracted with a consultant to assist with the impact analysis.
- Ian Aley provided a lesson learned from the MarketReady Program. What worked and what could be improved.
- Carrie Sanders provided an overview on New Market Tax Credits (NMTC) and the timing of these as it relates to Public Market funding and the reduction in their pricing.
- Sanders talked about 2020 projects have not received funding as expected because of the pandemic.
- Sanders informed the committee that any project receiving MNTC funding must remain "active" for seven years.
- Mikolajewski talked about a possible concern the City would have with liability associated in receiving NMTC funds for the project.
- Brent Pauba provided an update on the site plan, floor plan, and engineering plans for the project.
- Megan Ballard updated committee on the work The Foundation is doing to assist with the EDA Grant and mentioned there is a MarketReady press conference on September 24, 2020.
