PETITION FOR VARIANCE, AREA EXCEPTIONS OR APPEALS

2. 62197

650 Forward Dr. BLDVAR-2020-10975

The applicant is seeking a variance from 2015 IBC 507.5 requiring Group B, F, M, or S buildings that are no more than two stories above the grade plane, equipped throughout with an automatic sprinkler system in accordance with Section 903.3.1.1, and unlimited in area, to be surrounded and adjoined by public ways or yards not less than 60 feet in width. The proposed project contains an enclosed pedestrian walkway infringing upon the required 60 foot public way or yard space surrounding the building. Alder District #19.

Craig E. Brown made a motion to approve the variance as stated with the Fire Department's condition; seconded by Sam J. Breidenbach. The motion passed on a unanimous vote 7 - 0.
