Carusi asked Staff, how are you defining Small Cap Business program? Rolfs shared a handout and will email it to members and attach it in Legistar. Carusi asked if the "But..For Rule" had been met? Gromacki noted that it falls within the objectives of the law, also noting that it had been been done previously for housing, and was now extending to businesses. Gromacki said, given the pandemic, these are extenuating circumstances. Ramirez asked if there are plans for upgrading Pflaum Rd. Rolfs indicated he would have to follow up with City Engineering. Brasser asked if there will be a longer term donor plan in the future. Gromacki said that right now, a year-by-year approach makes more sense to see how everything goes. The City could can

then revisit in future once more is known.
