Presentation follows from attached slides. Reistad shared program materials and solicited feedback which was recorded on updated drafts.

Q: Will we be able to continue to support emergency food access?

Reistad: Yes, pantries and food banks would be more than welcome to apply.

Heckman: Emergency food providers are reporting that they currently have sufficient food, and would find value in more capacity grants at this point.

Q: Will the Food Access Improvement Map be used to target funds?

Heckman: the FAIM map will be updated when new data is available. There is reason to consider data beyond FAIM for this project, as COVID-19 has impacted the community widely

Q: Will the County PIE grants be involved?

Calkins: Yes, the PIE process will be released in tandem so that there are county opportunities for funding at the same time.

Q: What is the difference between the Healthy Community Food System Fund and potential funds for food entrepreneurs?

Reistad: Funds may be made available directly for food system entrepreneurs on a faster timeline while more general funds are available community-wide through the HCFSF

Q: What can be learned from the SEED grant process and business applications?

Reistad: We are hoping to see more partnership and community service goals, which hasn't always been present in business applications to SEED.

Discussion over the timeline suggests advancing this to the Common Council more rapidly to get grants in the hands of food system operator before growing season.

Motion: MFPC recommends that staff draft a resolution to be introduced at the 11/17/20 CC meeting for final passage at the 12/1/20 CC meeting to combine the remaining 2018/2020 HRAP funds with the 2021 Seed Grant funds to be divided into three programs:

- 1) \$150,000 for the Healthy Community Food Access Fund
- 2) \$100,000 for Rapid Food Access and Food Entrepreneur Support
- 3) \$18,000 for Regional Food System Planning

This would be a one year adjustment to conditions related to the COVID-19 pandemic and the Seed Grant program would return to its original funding and purpose in 2022.

Motion made by Kemble. Second by Brockel. Motion approved with unanimous consent.

Guffey Calkins led discussion of Food Systems Projects that can be prepared for future COVID-response funding. Discussion will be moved to the upcoming workgroup agendas.

The COVID-19 pandemic has reached crisis levels throughout Wisconsin. Within the last month, PHMDC has moved to crisis levels of contact tracing, where all positive cases are still notified, but contact tracing is not able to be conducted in all cases. Hospitalizations and ICU usage has increased following case surges in September and October, and those measures are at 82% and 81% of capacity.

Heckman has been doing site visits to pantries to ensure they are prepared for safe outdoor food distribution this winter.

- RFP Applications are now being accepted for Dane County's COVID-19 Community Development Block Grant program, totaling more than \$1.76 million. The funding will be spent on projects that prevent, prepare for, and respond to the COVID-19 pandemic, including projects that increase access to food, provide health services, and other areas. Application deadline is 2pm on Thursday, November 19th.

- Edible Startup Summit 2020 is virtual and also statewide this year - Monday & Tuesday, Nov. 9-10, 2020. We have two buses that make four stops each along established school bus routes in neighborhoods that have been identified with the highest need.

We also opened up another site for evening box pick up at our Food Production Center on Pflaum Rd. on Tuesdays from 4:00p – 6:00p to assist families that are unable to make it to our school sites during the day due to work schedules. We have been averaging about 120 boxes weekly.
