President of the Park Commission

President Emily Gnam reported that she had met the new Olbrich Gardens Director. The Mayor released a blog post with updates about the Reindahl encampment. Gnam highlighted item #67068 on the agenda and encouraged the commissioners to engage in discussion; as similar items are expected to come before the Park Commission later in the year. Next month, there will be an item discussing private funding and corporate sponsorships. A survey recently went out to Commissioners, as staff are working to set up a Glenway Golf Park tour for late September.

Superintendent of Parks

Superintendent Eric Knepp reported that the Mayor's Executive Capital Budget was released. Notable items in the budget include the Warner Park Community Recreation Center expansion, recreational biking, lakeshore work at Olbrich/Starkweather, and a reduction in the Vilas Park Masterplan. The Goodman Pool and Waves had a great year. The golf season is going very well and construction continues at Glenway. Knepp and Assistant Superintendent Christopher Peguero answered questions about plans for the Imagination Center at Reindahl Park.

The Commission recognizes the need for the City to address access to affordable housing in South Madison as represented by the CDA's proposal. The Commission supports the focus of City resources on the Cypress Spray Park and the Lincoln School property to better address the Parks needs of residents of the area consistent with the 2018-2023 Adopted Park and Open Space Plan.

Therefore in recognition of the overarching public benefit of additional low income housing, and the opportunity presented by greater park access and amenities in close proximity, the Commission is willing in this case to set aside its policy against removing parkland from the system. The Board of Park Commissioners hereby declares Hughes Park surplus to the needs of the park system.
