- o Funding Updates
- Mikolajewski said getting positive feedback from EDA but not sure of what the amount.
- Mikolajewski said Public Market fits well with Neighborhood Investment Fund (NIF) grant.
- Mikolajewski said the NIF ask was for \$4 million.
- Reynolds said Foundation applied for Tourism grant
- o Public Market Design Update
- Paube (Engeneering Staff) said the design documents are about 99.5% complete.
- Paube informed the committee that parking design approval process would be about six weeks.
- o Public Market Foundation Update
- Reynolds said they found a project coordinator will work about 10-12 hours/week.
- Reynolds felt the public phase of fundraising would begin soon.
- o Men's Shelter Update
- Mikolajewski said City should close on new property in early 2022.
- Mikolajewski felt construction could start in late-fall of 2022.
- Mikolajewski said Galway project next to Market has a tentative opening of spring 2023.
- Mikolajewski said always owners are very interested in working with the Market.
