William Orosz (registrant) provided public comment. Orosz owns the High Point Apartments and believes that properties in the area could see a higher density of residential development than the five stories proposed in the plan.

Eric McLeod (registrant) provided public comment. McLeod is an attorney representing West Towne Mall. McLeod argued that the proposed official mapping of streets through the West Towne Mall property constitutes a taking.

Joe DuPerre (registrant) provided public comment. DuPerre manages West Towne Mall and provided an overview of recent investments on the property.

Dan McAuliffe gave a presentation regarding the plan.

Bulgrin questioned the impact of proactive zoning on current businesses in the plan area. Several EDC members and staff conversed on what the impact might be.

Mendoza expressed concern about residents being priced out of the neighborhood.

Wehelie inquired about whether or not a formal RESJI Analysis had been completed for the plan; it had not.

Furman represents the planning area and expressed support for the plan.

EDC members discussed several options for a recommendation regarding the plan.

A motion was made by Furman, seconded by Lemmer, to Adopt the Odana Area Plan and Return to Lead with the Following Recommendation: RESJI analysis be done on the plan, but the RESJI Analysis and the Plan need not return to the EDC for formal action once completed. The motion passed by voice vote.
