DANE CARES Program: A Review in How Connecting Nutritious Food to the Community can also Benefit the Local Economy -- Michelle Orge, Second Harvest Foodbank of Southern WI

Presentation followed the attached slides w. Q&A after

- Q: What crops were requested based on planning with Farmers?
- A: Crops that can travel better or last longer.
- Q: What strategies are available for future funding and expansion?
- A: Financing is currently ARPA funds. Haven't yet thought about future plans after this subsides. May look to set aside specific funds, fundraise, or advocate for state funding.
- Q: What organizational changes occurred due to the program at SHFB? A: Some of the inventory systems and packaging methods have been enhanced and made more efficient through the logistics partnerships.
- Q: How did SHFB meet participant needs in terms of cultural appropriateness when also needing to move away from choice systems?
- A: Some direct distributions were done through mobile pantries. More self-select would occur at that level. Partner agencies are able to implement more choice opportunities.
- Q: Funding is quite generous from this program for farmers, how could any future funding streams come close to matching?
- A: Looking at ways to quantify the economic impact of programs like this in order to further the case that this work needs to continue.
- Q: How did the role of Farwell change from 2020 to 2021, and will that capacity be brought in-house or will there always be a need for third party logistics support?
- A: They have been able to plan further out with a much longer horizon on current funding project.

3 67577 Food Access, Relief, and Economic Support Work Group - September 2021

Over the course of several months, the group has undertaken the process of familiarizing itself with some of the past grantmaking efforts. Group began the process of formally identifying areas of recommendation for improvement to SEED and PIE grant processes.

With City's 2022 budget now finalized, there will not be a 2022 Community Food Access Grants fund as there was in 2021. MFPC/DCFC grantmaking will be limited to SEED, PIE, and HRAP pools.

- Task Force Core team also meets weekly

REGULAR BUSINESS REPORTS

9 <u>67583</u> Community Gardens - September 2021

Community garden organizers along with Rooted staff are working on preparing gardens for fall and winter, including winterizing water systems and cleaning up, planting vacant plots to cover crops so that they are ready for new gardeners in the spring. Rooted staff continue to work on finding alternate land for displaced community farmers in McFarland, and are exploring the possibility of a pilot community composting program at a garden to be determined, in the city of Madison.

The MMSD school year started on 9/2. Last spring, the USDA extended the waiver that all students enrolled in school have access to free breakfast and lunch every day for the entire school year.

MMSD is also providing meal pickup for the students enrolled in virtual learning for the school year. We currently offer a 5-day meal box and milk pickup at the following locations, every Monday from 2:00pm-4:00pm:

- LaFollette High loading dock behind school (take the driveway for Sennett Middle School and go through the parking lots behind both schools)
- Memorial High Door #6 Additionally, we have experienced along with the rest of the food industry, manufacturing shortages. Our primary distributor, Gordon Food Service (GFS), first reported observing inventory and supply chain issues caused by material shortages, increased demand for select products, and workforce challenges in late August. Deliveries are received for GFS thee days per week at our Production Center and shortages totaling hundreds of cases of product are observed with each delivery. We are continuing to partner with numerous vendors to try to always have our bases covered and solidified backup plans, to ensure that we will feed any students looking for breakfast and/or lunch each school day.

11 <u>67585</u> Double Dollars Program - September 2021

One month remaining of planned market season. At that point, Double Dollars will transition to the Willy Street Co-op.
