		The members discussed their availability for future meetings of the work group. They decided their next meeting would be Thursday, December 2, at 5:30pm.
3.	<u>67925</u>	Discussion of draft ordinance amendment regarding changes to the Common Council's Order of Business.
		One registrant spoke on this item.
		Foster updated the work group on what had been done since their last meeting, particularly regarding the RESJI analysis.
		Saqqaf provided background on RESJI and possible paths forward.
		Kapusta-Pofahl described to the members what she would need in the preliminary process for getting a RESJI analysis started.
		Chair Furman asked the members if they would like to separate the two proposals: order of business followed by a discussion early next year on how to move forward on start time. The members agreed they would like to do that.
4.	<u>67380</u>	Committee of the Whole meeting related to size and shape of Common Council, and appointments and chair of boards, committees, and commissions
		Kapusta-Pofahl stated that 14 alders responded to the Doodle poll, and 12 of those 14 indicated a possibility of being able to attend a Committee of the Whole meeting on December 17 from 4pm-6pm.
