Deputy Mayor Baumel shared a PowerPoint presentation on Boards, Committees and Commissions (BCC), which included the following:

- * Comparison of Madison's numbers to others
- * Recommended approach
- * Proposed process
- * Five draft survey questions

The work group members discussed options for the survey audience, including whether to request demographic information; whether to survey for standing committees and ad hoc committees separately or together; and the importance of wording for the survey questions.

Deputy Mayor Baumel will work to refine the survey questions and will work with Justice Castaneda to get a more professional eye to review the survey questions.

4. <u>67380</u> Committee of the Whole meeting related to size and shape of Common Council, and appointments and chair of boards, committees, and

commissions

The work group members discussed the four questions from the 2021 advisory referendum; if there was an expectation or if they have a commitment to put the questions on the ballot in 2023; and what they would do in terms of resourcing if they should decide to go ahead with a referendum in 2023.

At the next work group meeting, the members will go through each of the four questions and decide what they want to do.
