Ag Leases on City Owned Lands: The Policy Memo was shared with Economic Development Division (EDD) staff who deal with the City's leases – Matt Mikolajewski & Heidi Radlinger – and next steps were discussed with George Reistad on 1/6/22.

- Several leases have already been signed and recorded for 2022
- EDD staff will share the policy memo & set up meetings with relevant City Agency Staff
- Jess Guffey Calkins (Extension) will connect appropriate city agencies with Dane County Land & Water staff
- Staff will determine which of the remaining leases could be revised in 2022
- Appropriate staff will discuss potential revisions with current lessees
- If current lessees choose not to continue renting, begin to look for new farmers
- Revisions will be phased in as staff capacity and lessee negotiations allow in coming years

The UW-Madison Extension Community Food Systems Program has joined forces with the Wisconsin Women's Business Initiative Corporation (WWBIC) to pilot a virtual Spanish-language food entrepreneur showcase this month. Facilitated by WWBIC's Spanish-language business consultant Arlene Bollig and Comienzos, a Latino Business Assistance Partnership, the purpose of this series is to highlight the unique evolution of several Wisconsin-based food businesses owned and operated by native Spanish speakers. 11 69333 Double Dollars Program - Jan 2022

The new DD program Coordinator has started this week -- Marcus Slaton. Additionally, typically the year-end report for the DD program is distributed to those who request it by the end of Feb. However, it is likely that this will be a bit delayed this year as Marcus gets trained and acclimated to the position.

Willy St Co-op is seeing a 40% increase in issuance and redemption over the 3-year average. Community giving is up 18% in the most recent quarter.

Johns Hopkins Center for a Livable Future - Community of Learning
Practice - Jan 2022

The John Hopkins University Community of Learning and Practice on Racial Justice in Food Policy Councils met on January 12. We discussed our collective homework assignments where we were to begin reflecting on the power dynamics within our FPCs, the willingness to engage in discomfort, and how the structure of our FPCs may impact engagement. We also discussed the idea of Radical Respect: "I may not agree, but I am open to your ideas and understanding." Thank you to the 5 Dane County and 13 City of Madison FPC members who participated in our survey! Abha and Kirsten will be compiling a report out on the survey for future review. Before next month's COLP meeting February 2, we are asked to continue our reflections on the unwritten rules and norms that impact who has power on our FPCs and how power and culture informs the FPCs engagement efforts and policy making or recommendations.
