There is some consideration of placing an interim manager; or, CDD Managers will provide support with staff, budget, & program oversight. Karen Cator will attend Foundation meetings until a new Manager is hired.

# **Data Collection Overview**

- Surveyed 961 Madison residents between 8/11/21 to 10/22/21
  - Online survey developed by AARP
  - Survey promotions were sent out via AARP and Madison Age Friendly Steering Committee (various local events and newsletters)
- **5 community listening sessions** held in Fall 2021 and Winter 2022
  - Supplemented survey data on community strengths and challenges by reaching groups not strongly represented by those who took the survey.
  - ▶ 43 Madison residents participated (49% Black, 28% Latinx)























# **Community Survey Demographics**

- Lived in Madison at least 5 years (87%) 46% for 25+ years
- Lived in the 53704, 53703, 53705 or 53711 zip code (67%)
- **Bachelor's degree or higher (80%)**
- **Female** (71%)
- ► **Retired** (55%)
- Non-Hispanic/Latino (98%) and White (91%)
- Annual household income of \$50K or more (70%)
- **Broad range of ages:** 45-54 (16%), 55-64 (23%), 65-74 (43%), 75+ (17%)
- ▶ Shared household with others: 30% had other adult children, relatives or friends living with them; 9% with children under 18; 56% married or living with significant other.


# Overall Perceptions of Madison as a Community




# How would you rate your current community as a place for people to live as they age?




# 68% of Respondents Hope to Stay in Madison for their Future Years











# How important is it for you to be able to live independently in your own home as you age?














How likely is it that you will provide unpaid care to an adult loved one in the future?



## **Capturing Community Input**

The population of the United States is rapidly aging. By 2030, one of every five people in the U.S. will be 65 or older.

In the first of many steps to make our city more livable for adults age 65 and older, Madison became part of the AARP Network of Age-Friendly Communities in 2019. This is a part of the larger AARP Livable Communities initiative which supports the efforts of neighborhoods, towns, cities and rural areas to be great places to live for people of all ages. ## Surveying Madison Residents

A community survey was designed by AARP for Age Friendly Communities to help gather input on the 8 domains of livability. The online survey was completed by 961 Madison residents from 8/11/21 to 10/22/21. Survey promotions were sent out via AARP and Madison Age Friendly Steering Committee (various local events and newsletters).


Some Key Survey Respondent Demographics

- ⇒ Lived in Madison at least 5 years (87%)
- Lived in the 53704, 53703, 53705 or 53711 zip code (67%)
- ⇒ Bachelor's degree or higher (80%)
- $\Rightarrow$  Female (71%)
- Retired (55%)
- ⇒ Non-Hispanic/Latino (98%) and White (91%)
- Annual household income of \$50K or more (70%)
- Broad range of ages: 45-54 (16%), 55-64 (23%), 65-74 (43%), 75+ (17%)
- Shared household with others: 30% had other adult children, relatives or friends living with them; 9% with children under 18; 56% married or living with significant other.

### **Community Listening Sessions**

5 community listening sessions were also held in Fall 2021 and Winter 2022 to supplement data on community strengths and challenges by reaching groups not strongly represented by those who took the survey. 43 Madison residents participated (49% Black, 28% Latinx).

## Overall Survey Respondent Perceptions of Madison as a Community



68% of respondents hope to stay in their community in future years.

91% of respondents stated it was at least somewhat important to remain in their current community as long as possible.

25%+ respondents would strongly consider relocation for improved:

- Personal safety concerns
- Distance to family
- **Cost of living**
- Opportunities for social interaction












### Housing

Prioritizes providing older adults the opportunity to live in their current home or community as long as possible. Communities need to have a variety of suitable housing options and support home modifications as needed.

## Major Factors Influencing Respondents to Move **Out of Current Home**





91% of survey respondents stated that is was very or extremely important to live independently in their home as they age.

83% of respondents owned their own home

**37%** of respondents said their **homes** needed major repairs, modifications, or changes to enable them to stay there for as long as possible






### **Transportation**




