- 1. That said sanitary sewer, storm sewer, and street improvements (excluding bituminous surface pavement) be and are hereby accepted.
- 2. That said sanitary sewer improvements are hereby assigned to the Madison Sewer Utility for ownership and maintenance and that the attached Schedule "A" representing the actual cost of construction of these improvements shall be reflected in the Madison Sewer Utility's "Utility Plant In Service".

That said storm sewer improvements are hereby assigned to the Madison Storm Water Utility for ownership and maintenance and that the attached Schedule "A" representing the actual cost of construction of these improvements shall be reflected in the Madison Storm Water Utility's "Utility Plant In Service".

 - Autumn Lake Parkway from Golden Dusk Parkway to SW line, Lot 683.
 - Autumn Lake Parkway from Tranquility Trail to Tori Frost Drive.
 - Autumn Lake Parkway to Tori Frost Drive to OL 72.
 - Golden Dusk Parkway from 75' NW of Autumn Lake Parkway to Autumn Lake Parkway.
 - Tranquility Trail from Autumn Lake Parkway to Tori Frost Drive.
 - Tranquility Trail from Tori Frost Drive to Waterfall Way.
 - Tranquility Trail from Waterfall Wau to East Line, Lot 667.
 - Tori Frost Drive from Tranquility Trail to Caddisfly Lane.
 - Tori Frost Drive from Caddisfly Lane to Autumn Lake Parkway.
 - Waterfall Way from South line, Outlot 46 to Tranquility Trail.
 - Waterfall Way from Tranquility Trail to Caddisfly Lane.
 - Waterfall Way from Caddisfly Lane to Outlot 72.
 - Waterfall Way from Outlot 72 to North line, Lot 1223.
 - Caddisfly Lane from Tori Frost Drive to Waterfall Way.
 - OL 46/47 Path from West line, Lot 669 to Waterfall Way.
 - OL 46/47 Path from Waterfall Way to East line, Lot 667.
 - OL 72 Alley from Autumn Lake Parkway to Waterfall Way.
 - OL 57 Alley from Tranquility Trail to Autumn Lake Parkway.
 - OL 59 Alley from Tori Frost Drive to Waterfall Way.
 - OL 73 Sidewalk from Tranquility Trail to Autumn Lake Parkway.

The attached Schedule "A" representing the actual cost of construction of these improvements, which shall increase the street infrastructure value for Project No. 13303 by \$ 783,299.39 for a useful life of 40 years.
