This agreement will provide assistance to Metro Transit for providing transit information services, promotion efforts and operations in the amount of \$19,280. It will also provide \$12,850 in assistance to the MPO and Planning unit for coordination of specialized transportation services. The funds are included in the respective 2007 Operating budgets. No impact on levies or cost controls.

WHEREAS, the 2007 Dane County budget includes a Transit and Environmental program in the Highway and Transportation Department; and

WHEREAS, this budget includes funding support for Metro Transit in the amount of \$19,280 for Transit information service, promotion efforts and operations for the calendar year 2007 and for \$12,850 to the Madison Area Metropolitan

Planning Organization (MPO) and Planning Unit to support the 2007 Dane County coordination activities; and

WHEREAS, Metro Transit and the MPO and Planning Unit have included these amounts in their respective 2007 budgets;

NOW, THEREFORE BE IT RESOLVED that the Mayor and City Clerk are authorized to enter into an agreement with Dane County for providing services to Metro Transit and the Madison Area Metropolitan Planning Organization and Planning Unit for the 2007 calendar year for a total of \$32,130.
