Fiscal Note

The proposed resolution reclassifies Metro's Transit Information Systems Specialist position #3882 from CG44 -RG8 to CG44-RG10. The total annualized increase in cost for salary and benefits associated with the reclassification is \$6,050. Metro Transit plans to absorb this increase within the adopted 2018 operating budget with savings provided by vacant positions and turnover throughout their authorized position roster in 2018.
