DRAFTER'S ANALYSIS: This ordinance creates the classification of "Disability Rights and Program Services Specialist" in Compensation Group 18, Range 04, and deletes the classification of "Disability Rights and Program Services Coordinator" in Compensation Group 18, Range 08.

The Common Council of the City of Madison do hereby ordain as follows:

Subdivision (b) of Subsection (1) of Section 3.54 entitled "Compensation Plan" of the Madison General Ordinances is amended by creating the classification of "Disability Rights and Program Services Specialist" in Compensation Group 18, Range 04, and deleting the classification of "Disability Rights and Program Services Coordinator" in Compensation Group 18, Range 08, thereof.
