WHEREAS, in 2006 the Madison Senior Center engaged 300 volunteers of all ages in contributing 9,191 hours of service to the Senior Center and the community; and

WHEREAS, the Madison Senior Center Foundation, Inc. has recently received one of twelve special grants in the nation from the National Council on Aging; and

WHEREAS, this grant will enhance the Madison Senior Center volunteer program and mobilize highly skilled professionals who are 50 years of age and better in new volunteer roles; and

WHEREAS, the Madison Senior Center must accomplish specific tasks associated with this grant for the period July through December, 2007; and
