**Fiscal Note**

The proposed resolution approves plans and specifications and authorizes the Board of Public Works to advertise and receive bids for the 2018 Park Paving project. The total estimated cost of the project is \$210,000, \$70,000 of which will be funded by the Engineering Division’s Bikeways Program budget. The Parks Division 2018 Capital Budget includes \$1,821,000 for Park Land Improvements (Munis project 17421) and the Engineering Division 2018 Capital Budget includes \$781,000 for Bikeway Programs (Munis project 10138). Funding is available in this project.
