## BE IT HEREBY RESOLVED:

- 1. That the Common Council of the City of Madison hereby establishes an assessment district known as the Resurfacing 2019- Assessment District all in accordance with Section 66.0701 (formerly Section 66.62) of the Wisconsin State Statutes and Section 4.09 of the Madison General Ordinances.
- 2. That the contemplated purposes of this assessment district is to remove and replace storm sewer, deteriorating concrete curb and gutter, sidewalks and driveways as needed.
- 3. That the benefited properties shall have the opportunity to pay the special assessments which may be levied as a result of this assessment district in eight (8) annual installments, subject to the current interest rate in effect at the time of the establishment of the special assessment.
- 4. That the city Engineer is hereby directed to prepare a report consisting of preliminary or final plans and specifications; an estimate of the entire cost of the proposed work or improvements within the assessment district; a schedule of proposed assessments, constituting an exercise of police power of the City of Madison; and a statement that the property against which the assessments are proposed is
