Fiscal Note

Revenues are anticipated in the 2008 Sewer, Stormwater, and Landfill operating budgets. No additional appropriation is required.

Title

Amending the title of Chapter 35 of the Madison General Ordinances to remove the reference to “drainage”, amending Sections 35.02(7) and 35.025(4) of the Madison General Ordinances to establish 2008 Sewer Utility Rates (including Landfill Remediation Fees) effective January 1, 2008, and amending Section 37.05(4) of the Madison General Ordinances to establish 2008 rates for the Public Stormwater System.

Body

DRAFTER'S ANALYSIS: This ordinance establishes the sewer utility rates and landfill remediation fees as well as the stormwater utility rates for 2008.

The Common Council of the City of Madison do hereby ordain as follows:

- The Title of Chapter 35 of the Madison General Ordinances is amended to read as follows:
“The Public ~~Drainage and~~ Sewerage System”
- Subsection (7) entitled "Schedule of Demand Charges, Sewer Rental, Miscellaneous Charges and

Industrial Cost Recovery Charges" of Section 35.02 entitled "The Public Sewerage System" of the Madison General Ordinances is amended to read as follows:

"(7) Schedule of Demand Charges, Sewer Rental, Miscellaneous Charges and Industrial Cost Recovery Charges.

(a) Demand Charges.

1. 5/8" meter \$45.50
3/4" meter 45.50
1" meter 93.05
1 1/2" meter 172.30
2" meter 267.40
3" meter 489.30
4" meter 806.30
6" meter 1,598.80
8" meter 2,549.80
10" meter 3,817.80
12" meter 5,085.80
2. The demand charges for each six (6) months period for meters which only measure water usage, said charges being necessary to recover the Madison Sewer Utility's cost and which are in addition to the demand charges levied by the Water Utility, shall be as follows:
5/8" meter \$10.20
3/4" meter 10.20
1" meter 13.80
1 1/2" meter 19.80
2" meter 27.00
3" meter 43.80
4" meter 67.80
6" meter 127.80

(b) Sewer Rental.

1. The sewer rental for those customers who do not elect or are not required to monitor the characteristics of their effluent shall be ~~\$1.1647~~ \$1.2300 per one hundred (100) cubic feet of wastewater contributed.
2. The sewer rental for those customers who elect or are required to monitor the characteristics of their effluent shall be ~~\$0.5262~~ \$0.5534 per one hundred (100) cubic feet of waste contributed, plus ~~\$0.4482~~ \$0.1237 per pound of Carbonaceous Biochemical Oxygen Demand, plus ~~\$0.1905~~ \$0.1934 per pound of suspended solids, plus ~~\$0.3409~~ \$0.3404 per pound of nitrogen as measured Total Kjeldahl Nitrogen, plus ~~\$1.8465~~ \$1.8012 per pound of Total Phosphorous.

(c) Schedule of Charges Where Measurement of Sewer Rental is Not Practical .

Where the Engineer has determined that the measurement of the volume of sewage or industrial waste contributed is not practical, s/he is authorized to establish a flat rate charge for sewer rental and demand charges, the minimum flat rate charge to be ~~\$96.75~~ \$99.62 for each semi-annual bill.

(d) Schedule of Charges for Septic Tank Waste. The charge for discharges of waste (from septic tanks, industrial or domestic waste holding tanks, seepage pits, grease traps, mobile public toilets, permanent or portable privies or liquid industrial waste) at the City Engineering Division's Facility located at 1602 Emil Street, or at any other approved site on the Public Sewerage System shall be \$21.00 per load plus \$11.65 for each additional one thousand (1,000) gallons in excess of the first one thousand five hundred (1,500) gallons. Waste containing approximately 10,000 milligrams per liter of 5-day Biochemical Oxygen Demand (BOD5) or 20,000 milligrams per liter of suspended solids shall be considered "average" waste for the purpose of this subsection. The City Engineer is authorized to establish a modified schedule of

charges based on the unit cost established in accordance with Sec. 35.02(7)(b)2 for septic tank waste which materially differ in strength from the average."

3. Subsection (4) entitled "Schedule of Landfill Remediation Fees" of Section 35.025 entitled "Landfill Remediation" of the Madison General Ordinances is amended to read as follows:

"(4) Schedule of Landfill Remediation Fees. The Landfill Remediation Charge for each six (6) month period shall be in addition to the demand charges established by Section 35.02(7) of these ordinances and shall be in accordance with the following schedule:

5/8-inch meter	\$9.00	<u>\$8.00</u>
3/4-inch meter	9.00	<u>8.00</u>
1-inch meter	28.00	<u>25.00</u>
1 1/2-inch meter	67.00	<u>60.00</u>
2-inch meter	121.00	<u>108.00</u>
3-inch meter	266.00	<u>236.00</u>
4-inch meter	503.00	<u>447.00</u>
6-inch meter	1,197.00	<u>1,064.00</u>
8-inch meter	2,153.00	<u>1,914.00</u>
10-inch meter	3,575.00	<u>3,177.00</u>
12-inch meter	5,121.00	<u>4,552.00</u>

The foregoing schedule shall apply to all customer bills issued on or after January 1, 2007 ~~2008~~. For the purpose of calculating the bills for the customers of the Sewer Utility, the Landfill Remediation Charge may be added to demand charges established by Section 35.02(7)."

4. Subdivision (f) "Rate Structure" of Subsection (4) entitled "Rates and Charges" of Section 37.05 entitled "The Public Stormwater System" of the Madison General Ordinances is amended to read as follows:

"(f) Rate Structure. Effective January 1, 2007 ~~2008~~, the following schedule of rates and charges re in effect:

1. The Customer Charge for each six months shall be ~~\$3.35~~ \$3.90 for each lot or parcel of land.
2. The Impervious Area Charge for each six months shall be ~~\$7.44~~ \$8.67 per 1,000 square feet of Impervious Area.
3. The Pervious Area Charge for each six months shall be ~~\$0.52~~ \$0.61 per 1,000 square feet of Pervious Area."
