### Fiscal Note

The agreement provides for the reimbursement by Dane County for all fixed route and ADA paratransit trips provided by Metro Transit to Dane County employees during the contract term. Metro Transit shall be reimbursed \$1.15 per fixed route trip based on the actual ridership during the first year of the agreement (April 1, 2013 through March 31, 2014). Fixed route rides for subsequent years of the agreement will be billed at the per ride rate in effect in the fare tariff at the time the ride is taken. Paratransit rides will be billed by actual ridership at the per ride rate in effect at the time the ride is taken. Estimated revenue will be included in Metro's operating budget for each year of the agreement. Estimated revenue for 2013 is \$24,000. Estimated revenue for 2014 is \$25,000.

### Title

### Body

WHEREAS, Metro Transit and Dane County have had a successful partnership with this pass program in the

past; and

WHEREAS, the parties have negotiated a contract which meets all Transit and Parking Commission criteria set in advance for unlimited ride pass agreements;

NOW THEREFORE BE IT RESOLVED that the Mayor and the City Clerk are authorized to enter into a one year unlimited ride pass agreement with four one-year automatic renewals with Dane County with reimbursement by Dane County for all trips taken by Dane County employees during the term of the agreement.
