**Fiscal Note**

The proposed resolution deletes the classification of Housing Operations Analyst in CG 18, Range 8, recreates the classification in CG 18, Range 12, and reallocates the incumbent to the new position. The estimated cost in 2022 is \$13,000, including benefits and will be funded through salary savings in other positions in the CDA Housing budget. The annual estimated cost is \$20,600, including benefits.
