WHEREAS, Gregory Banks was an inspiration to everyone as he battled ALS, never allowing this disease to get in his way; and

WHEREAS, Gregory Banks, with the constant support and assistance of his dedicated wife and partner Gennette, would lead by example to all those who served with and knew him; and

WHEREAS, Gregory Banks exhibited limitless joy and enthusiasm to all of those he came in contact with; and WHEREAS, Gregory, age 55, passed away on Friday, September 30, 2011 at home surrounded by his loving family.
