DRAFTER'S ANALYSIS: Rezone 6733 Fairhaven Road.

1. WHEREAS, an Amended PUD(GDP) Planned Community Development (General Development Plan) District has been duly filed for approval of the Madison Common Council and is hereby made an integral component of the zoning district regulations.

NOW, THEREFORE, the Common Council of the City of Madison do ordain as follows: Paragraph 3292. of Subdivision (a) of Subsection (2) of Section 28.06 of the Madison General Ordinances is hereby created to read as follows:

"28.06(2)(a)3292. The following described property is hereby omitted from the PUD(GDP) Planned Unit Development (General Development Plan) District and W Wetland District and added to the PUD(GDP) Planned Unit Development (General Development Plan) District:

Lot 1, CSM #12128, City of Madison, Dane County, Wisconsin. This parcel contains 26,271 square feet or 0.60 acres." 2.
