DRAFTER'S ANALYSIS: This ordinance establishes the 2006 Common Council meeting schedule.

The Common Council of the City of Madison do hereby ordain as follows:

Subsection (1) of Section 2.01 entitled "Meetings" of the Madison General Ordinances is amended to read as follows:

"(1) The stated meeting of the Common Council shall be held in the Council Chambers on the first and third Tuesdays of every month at 6:30 p.m., except in August and December the Common Council will meet only on the first Tuesday; provided, however, that a meeting shall be scheduled for November 16, ~~2004~~ 15, 2005 for the purpose of adopting the ~~2005~~ 2006 Capital and Operating Budgets; ~~that the regularly scheduled meeting of February 15, 2005 shall be rescheduled to February 22, 2005; that the regularly scheduled meeting of April 5, 2005 shall be rescheduled to March 29, 2005; that the regularly scheduled meeting of April 19, 2005 shall begin at 12:00 noon; that the regularly scheduled meeting of July 4, 2006 shall be rescheduled to July 11, 2006; that the regularly scheduled meeting of October 4, 2005 shall be rescheduled to October 11, 2005; that the regularly scheduled meeting of November 1, 2005 shall be rescheduled to November 8, 2005; that a meeting shall be scheduled for November 15, ~~2005~~ 15, 2006 for the purpose of adopting the ~~2005~~ 2007 Capital and Operating Budgets; that the regularly scheduled meeting of November 15, 2005 shall be rescheduled to November 29, 2005; and that the regularly scheduled meeting of December 6, 2005 shall be rescheduled to December 13, 2005."~~
