The proposed resolution approves plans and specifications and authorizes the Board of Public Works to advertise and receive bids for the Warner Park Boat Launch Parking Lot Reconstruction. The Parks Division 2018 adopted capital budget includes \$1,360,000 funded by GO Borrowing (\$850,000), Impact Fees (\$500,000) and Private Contributions / Donations (\$10,000) for the Beach and Shoreline Improvements project (Munis project 10605). The total estimated cost of this project is \$1,200,000. Funding is available in the project.
