**Fiscal Note**

The cost for 2016 is approximately \$8,300. There are three Information Technology (IT) reclass resolutions (40854, 40855, and 40856) introduced, of which this is one. The cost for 2016 of the three reclasses is approximately \$24,700. IT will need to monitor their salary savings throughout the year to fund these reclassifications.

**Title**

Recreate the 1.0 FTE position #810 of "IT Specialist 3" (CG18/10, currently occupied by E. Olson) as "IT Specialist 4" (CG18/12, class code H248) in the Information Technology budget and reallocate the incumbent to the new position.

**Body**
