### **Fiscal Note**

The estimated additional cost in 2011 for the reclassification of this position (budgeted at .80 FTE) and reallocation of the incumbent is \$582 in salary expense, plus \$247 for benefits (\$829 total). The estimated annual cost of the reclassification is \$2,968 in salary expense, plus \$1,261 for benefits (\$4,229 total). Funding for 2011 will be accommodated in the DCR adopted operating budget.
