Fiscal Note

The proposed resolution approves the use of Safe Routes Grants funding for installation of new sidewalk on Steensland Drive and Hooker Avenue at a total estimated cost of \$15,000. The Safe Routes Grants Program pays 50% of a property owner's sidewalk assessment where new sidewalk is installed on eligible projects. The 2021 Capital Budget for Engineering-Bicycle and Pedestrian has \$100,000 budgeted for the Safe Routes Grants program (MUNIS 11112). Funding for this program is from GO borrowing.
